- The MS/MPhil and PhD Rules and Regulations-2023, along with any amendments, will be implemented for scholars registered in the respective Department/Centre/ Institute, University of Balochistan (UoB), Quetta.
- The coursework classes for the 1st semester will commence from **15th March-2025**.
- The last date for fee collection after the display of the merit list is **31st January-2025**. No fee voucher or admission will be considered valid beyond this date.
- 75% attendance is Mandatory for every Semester, otherwise, Enrollment will stand struck off.
- Any Candidate who is found at any time to have obtained admission by any Misstatement in the admission form by willful concealment of any Pervious admission or employment fact or used a FAKE document (e.g. CNIC, Local/Domicile and Academic Document etc) shall be punished as per UoB rules and even after completion of course that can lead to the cancellation of degree in any time in future.
