The Item No.6 was taken and resolution passed thereon by the Advanced Studies & Research Board in its 169th meeting held on 3rd June-2023 is reproduced below:

Item No.06 **Consideration of the Minutes of the Meeting of Graduate Studies Monitoring Committee "GSMC" Regarding Cases forwarded by the AS&RB & Others**

Resolution: The Board resolved to approve the Minutes of the meeting of Graduate Studies Monitoring Committee "GSMC" and recommendations of the Committee with some amendments in its meeting held on 13th June 2022 with the following amendments.

Sub-Item No. 01: TO CONSIDER AND DISCUSS THE ADMISSION OF SPRING SESSION 2023 IN LIGHT OF DAC MINUTES RECEIVED FROM VARIOUS DEPARTMENTS / CENTERS AND INSTITUTES

Chairman Graduate Studies briefed the GSMC members regarding the announcement of MS / MPhil and PhD admission in various Departments / Institutes and Centers in the University of Balochistan, Quetta for Spring Session 2023 and the admission committee agreed on the following placed below points:

Resolution: After a detailed deliberation the committee members resolved to secure the admissions of Spring-2023 and to advertise the admission of Fall-2023 in all those Departments/Centers/Institutes where either number of passed candidates are less than the required or where the slots have been created. The committee also recommended starting the semester in August 2023. The following timeline shall be observed:

- GSO shall collect data from departments by 16th June 2023.
- Advertisement shall be published in Daily newspaper on 18th June 2023.
- The last date of admission forms submission shall be 28th June 2023.
- The date of admission forms submission may be extended till 7th July 2023.
- The data to issue Roll number slips etc. shall be handed over to the IT department on 15th July 2023.
- The entrance test shall be conducted on 22nd and 23rd July 2023.
- List for the conduct of interviews shall be sent to respective departments on 31st July 2023
- After approval from the competent authority the final merit list shall be displayed with a timeline for fee submission till 11th August 2023.
- Classes of the said programs shall be started from 15th August 2023.
- Mid semester exam shall be on 9th October 2023
- Commencement of classes from 16th October 2023
- Final Semester exam shall be on 18th December 2023
- The result announcement and submission to the controller shall be on 26th December 2023.

a. MPhil Study Program
